### D. **For Possible Action** –FY18 3rd Quarter Jackpot Grant Panel Funding Recommendations ---

Review, discussion and possible approval of grant funding panel recommendations. Fifteen applications were received for the FY18 3<sup>rd</sup> Quarter Jackpot Grant Program. One application scored below the established funding threshold of 60%. Panel recommended \$11,639.99 in funding for 14 applicants. Available funding is \$10,000. Board to determine funding. The panel was chaired by board member Mark Salinas.

Jackpot Quarterly Grants of up to \$1,000 are designed to support first-time or sudden opportunity arts and arts learning/education projects initiated by artists, teaching artists, schools, nonprofit organizations, and public institutions.
